

# Income Earnings Disclosure 2019

Team National (TN) has created this Income Earnings Disclosure to help individuals understand the compensation they can earn as a TN Independent Marketing Director (IMD). Yet, each IMD's experience and success, or lack thereof, will vary based on the time, effort and leadership put forth in building his business. If you are someone that seeks to build a part-time or full-time income, we want you to have realistic expectations of your possible earnings.

The income in the chart is for all U.S. TN IMDs who were eligible to earn downline commissions in 2019. An Independent Marketing Director (IMD) is a distributor that is currently registered as eligible to represent TN to market and sell TN products and services, and to sponsor a downline sales organization.

In 2019, 12.6% of IMDs received commission or bonus income, 87.4% of all received no income, and of all IMDs, the average earnings were \$635.70. 7.6% of all made 2 or more sales.

The above income for the Platinum and Double Platinum levels include leadership bonuses, combined business centers, and leadership meeting attendance bonuses.
