When points occur on your Left Team or your Right Team, by anyone on either team, regardless of who their sponsor is, YOU earn points. Points begin to accumulate immediately upon joining. When your accumulated points are at least 500 for each Team, your points will CYCLE and you have an opportunity to earn a commission. On each CYCLE, the points are removed from your team totals and if you are qualified, you will be paid \$500 commission. You can continue to accumulate and CYCLE points many times during the week and you will continue to be paid commissions based on your level of achievement. You can earn up to \$7,000 per week.

Qualification Requirements: To earn commissions you must qualify by personally selling memberships. Each achievement level is outlined here with definitions at the end of this document.

Gold	8 Active Left & Right	\$7,000	1 Silver Left & Right

Achievement Levels - As you increase in Achievement Level, so does your commission potential.

Personal Members (Left & Right) - In order to increase in Achievement Level, it is necessary to sell memberships.

Weekly Max - This is the maximum amount of commission allowed to earn at each Achievement Level. Point totals on your lesser team will not carryover to the following week once your have earned your maximum commission at your current Achievement Level.

Personal Member Requirements - To advance to the next Achievement Level, it is necessary to help those on your team to also advance. Your personally enrolled Members can be at a higher Achievement Level than listed above for you to reach the next levels. They may also be at a higher Achievement Level than you.

Active Member - In order to remain active, you must generate a minimum of 20 points a month, this can be done by purchasing a coin of the month or selling a new membership. If you have not generated 20 points in a 32 day period you become inactive.
